**DECLARING THE COMPETITIVE BIDDING FOR THE  
PROJECT "PHOTO AND VIDEO COVERAGE AND PRODUCTION  
WITH SAME-DAY-EDIT DURING THE 21ST NATIONAL PESO  
CONGRESS" A FAILURE**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱400,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 09 July 2021 to 03 August 2021;

**WHEREAS**, said project is included in the 2021 Annual Procurement Plan of the Department;

**WHEREAS**, the Pre-bid Conference which was originally scheduled on 20 July 2021 was postponed moved on 23 July 2021 was attended by lone prospective bidder M&P Productions Co./M&P Creatives Co.;

**WHEREAS**, the submission and opening of bids scheduled on 03 August 2021 and likewise moved on 10 August 2021 was attended by lone bidder M&P Productions Co./M&P Creatives Co. Said bidder submitted its technical and financial component in one envelope. Upon preliminary examination, the technical proposal of M&P Productions Co./M&P Creatives Co. was rated as "**failed**" in view of non-submission for the technical component and financial component in a two (2) separate envelopes as required in Items 10 and 11 of the Bidding Documents;

**WHEREAS**, the BAC informed the representative for M&P Productions Co./M&P Creatives Co. that they have an option to file for a Motion for Reconsideration (MR) within three (3) days from the date of opening of bids;

**NOW, THEREFORE**, for and in consideration of the foregoing, We, the members of the Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare the competitive bidding a "**failure**" in view of non-submission for the technical component and financial component in a two (2) separate envelopes as required in Items 10 and 11 of the Bidding Documents for

the Bureau of Local Employment project “Photo and Video Coverage and Production with Same-Day-Edit during the 21st National PESO Congress”;

- b. To recommend for “**Re-Bidding**”; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
