**DECLARING S.D. LEAL GRAPHICS AS THE LOWEST CALCULATED
AND RESPONSIVE BIDDER FOR THE PROJECT
“DIGITAL PRINTING OF BWC 2020 ANNUAL REPORT”**

WHEREAS, the Department of Labor and Employment (DOLE), through the Bureau of Working Conditions (BWC), requisitioned the “Digital Printing of BWC 2020 Annual Report” with a total Approved Budget for the Contract of ₱150,000.00;

WHEREAS, the said activity is included in the 2021 Annual Procurement Plan of the Department;

WHEREAS, DOLE BAC Resolution No. 54, Series of 2021 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 01 July 2021;

WHEREAS, DOLE advertised the Request for Price Quotation for the procurement of the above-mentioned project in the DOLE Website, and Philippine Government E-Procurement System (PhilGEPS) from 01 to 06 July 2021;

WHEREAS, in response to the advertisement, nine (9) bidders, namely: 1) Innovation Printshoppe, Inc.; 2) S.D. Leal Graphics; 3) Work Habits Trading; 4) Neo-Pro Enterprises; 5) VJ Graphics, Inc.; 6) GA Printing, Inc.; 7) Dolmar Press, Inc.; 8) Kayumanggi Press, Inc.; and 9) Gilcor Printing Press submitted Bid Proposals on the opening of bids scheduled on 06 July 2021;

WHEREAS, the BAC-TWG recommended S.D. Leal Graphics as the Lowest Calculated Bidder based on the Abstract of Price Quotations and was declared **responsive** as indicated in the post-qualification report under small value procurement;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the DOLE BAC hereby resolve as it is hereby **RESOLVED**:



- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.


