CONTRACT AGREEMENT

THIS AGREEMENT, made this 16 SEP 2021 day of _____, 2021 by and between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary ANA C. DIONE, CPA**, hereinafter called the “**DOLE**” and **BUSINESS UNUSUAL MEDIA SOLUTIONS, INC.** with office address at One Global Place 25th Street and 5th Avenue Taguig City represented by its Authorized Representative, **MR. MICHAEL B. QUILILAN**, hereinafter called the “**Service Provider**”.

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, viz., of the project “**Photo and Video Coverage and Production with Same-Day-Edit during the 21st National PESO Congress – Re-Bidding**” for the **Bureau of Local Employment** and the **DOLE** has accepted a total Bid of **Three Hundred Twenty-Eight Thousand Pesos only (₱328,000.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General Conditions of Contract;
 - iv. Special Conditions of Contract;
 - b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents / statements submitted;

Bid form including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - c. Notice of Award of Contract and Bidder’s conforme thereto;
 - d. Performance Security; and

- e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice To Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Three Hundred Twenty-Eight Thousand Pesos only (P328,000.00)** or such other sums as may be ascertained, the **Service Provider** agrees to provide the project **“Photo and Video Coverage and Production with Same-Day-Edit during the 21st National PESO Congress – Re-Bidding”** for the **Bureau of Local Employment** in accordance with its Bid.
4. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




