**DECLARING MANILA BULLETIN PUBLISHING CORPORATION (MANILA BULLETIN)
 AS THE LOWEST CALCULATED RESPONSIVE BIDDER FOR THE PROJECT
 "NEWSPAPER PUBLICATION OF THE HIGHLIGHTS OF
 21ST NATIONAL PESO CONGRESS"**

WHEREAS, the Department of Labor and Employment (DOLE), through the Bureau of Local Employment (BLE), requisitioned for the project "Newspaper Publication of the Highlights of 21st National PESO Congress" with a total Approved Budget for the Contract of ₱585,000.00;

WHEREAS, pursuant to approved BAC Resolution No. 083, Series of 2021, the BAC recommended Negotiated Procurement under Section 53 of the 2016 Revised IRR of RA 9184 specifically under Section 53.6 – Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services as the method of procurement for the abovementioned project;

WHEREAS, based on the canvass made by BLE, three (3) newspaper publications, namely: (1) Manila Bulletin Publishing Corporation (Manila Bulletin), (2) Business World Publishing Corp. (Business World), and (3) PhilSTAR Daily, Inc. (The Philippine Star), submitted their price proposals and is summarized in the Abstract of Price Quotations submitted by the BLE, wherein the lowest bid price among the three (3) bidders is the price quoted by the Manila Bulletin Publishing Corporation (Manila Bulletin);

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Manila Bulletin Publishing Corporation (Manila Bulletin), its bid has been found to be responsive;

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolve as it is hereby **RESOLVED**:

- a. To declare **Manila Bulletin Publishing Corporation (Manila Bulletin)** as the Lowest Calculated and Responsive Bidder for the project "Newspaper Publication of the Highlights of 21st National PESO Congress";
- b. To award the project "**Newspaper Publication of the Highlights of 21st National PESO Congress**" to Manila Bulletin Publishing Corporation (Manila Bulletin) at a contract price of **₱307, 722.24**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
