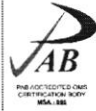

**DECLARING CHRISTIAN STEPHEN GARMENTS AS THE LOWEST  
CALCULATED AND RESPONSIVE BIDDER FOR THE BUREAU OF LOCAL  
EMPLOYMENT PROJECT "SUPPLY AND DELIVERY OF JOBSTART CUSTOMIZED  
BOMBER JACKET FOR PROGRAM IMPLEMENTERS AND STAKEHOLDERS"**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱246,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 31 August 2021 to 21 September 2021;

**WHEREAS**, said project is included in the FY 2021 Annual Procurement Plan of the Department;

**WHEREAS**, the Pre-bid Conference which was originally scheduled on 07 September 2021 and has been moved from 08 September 2021 to 21 September 2021 and was attended by lone prospective bidder Tanjer Enterprises;

**WHEREAS**, Supplemental/Bid Bulletin No. 13 was issued to amend and clarify some provisions originally indicated in the Bidding Documents;

**WHEREAS**, in response to the advertisement, two (2) bidders namely: (1) Tanjer Enterprises; and (2) Christian Stephen Garments purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 22 September 2021 to 30 September 2021;

**WHEREAS**, the submission and opening of bids originally scheduled on 21 September 2021 was likewise moved on 05 October 2021 was attended by two (2) bidders namely: (1) Tanjer Enterprises; and (2) Christian Stephen Garments. Said bidders submitted its technical and financial envelopes. After preliminary examination, the technical proposals of Christian Stephen Garments and Tanjer Enterprises were rated as "**passed**" hence, the BAC opened their financial envelopes which were also rated as "**passed**";

**WHEREAS**, the BAC - TWG in its bid evaluation report dated 05 October 2021 as duly concurred by the members of the BAC, examined and evaluated the bid proposals of Christian Stephen Garments and Tanjer Enterprises;

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, Christian Stephen Garments and Tanjer Enterprises complied with the mandatory minimum specifications of the said project. Christian Stephen Garments was declared as the Lowest Calculated Bidder per BAC Resolution No. 093, Series of 2021;

**WHEREAS**, BAC Secretariat sent a letter to Christian Stephen Garments requesting for submission of post-qualification documents;

**WHEREAS**, Christian Stephen Garments submitted additional documents for post-qualification;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Christian Stephen Garments, its bid has been found to be responsive;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Christian Stephen Garments** as the **Lowest Calculated and Responsive Bidder** for the **Bureau of Local Employment** project “**Supply and Delivery of JobStart Customized Bomber Jacket for Program Implementers and Stakeholders**”;
- b. To award the project “**Supply and Delivery of JobStart Customized Bomber Jacket for Program Implementers and Stakeholders**” for the **Bureau of Local Employment** to **Christian Stephen Garments**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.


