**DECLARING THE COMPETITIVE BIDDING FOR THE  
PROJECT "SUPPLY AND DELIVERY OF VARIOUS ADVOCACY  
MATERIALS FOR NERS 1 MILLION JOBS FOR 2021" A FAILURE**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱498,600.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 18 October 2021 to 09 November 2021;

**WHEREAS**, the said project is included in the 2021 Annual Procurement Plan of the Department;

**WHEREAS**, the Pre-bid Conference which was scheduled on 26 October 2021 was attended by lone prospective bidder Rulujac Enterprises;

**WHEREAS**, in response to the advertisement, no prospective bidder purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 18 October 2021 to 09 November 2021;

**WHEREAS**, no prospective bidder attended the scheduled submission and opening of bids which was scheduled on 09 November 2021;



- b. To recommend that a re-bidding be conducted; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.


