**DECLARING GLOBAL-LINK EXHIBITIONS SPECIALIST, INC. AS THE
SINGLE RATED AND RESPONSIVE BIDDER FOR THE PROJECT “PROCUREMENT
OF VIRTUAL EVENT MANAGEMENT SERVICE PROVIDER
FOR THE 5TH NATIONAL CAREER ADVOCACY CONGRESS (NCAC)
WEBINAR SERIES AND CULMINATING ACTIVITY”**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Request for Expression of Interest for the re-bidding of the abovementioned project with an Approved Budget for the Contract (ABC) of ₱1,100,000.00 in the Philippine Government E-Procurement System (PhilGEPS) and DOLE websites and conspicuous places at the DOLE's premises from 14 to 21 September 2021;

WHEREAS, said project is included in the FY 2021 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, only Global-Link Exhibitions Specialist, Inc. submitted a Letter of Intent signifying its interest to participate in the bidding;

WHEREAS, the submission and opening of eligibility documents scheduled on 21 September 2021 was attended only by Global-Link Exhibitions Specialist, Inc. Upon eligibility check, said bidder was declared eligible;

WHEREAS, the BAC Technical Working Group (TWG) examined and evaluated the eligibility documents submitted by Global-Link Exhibitions Specialist, Inc. using the Shortlist Criteria in the Annex A of the Terms of Reference;

WHEREAS, pursuant to approved BAC Resolution No. 084, Series of 2021, Global-Link Exhibitions Specialist, Inc. is declared as the Lone Shortlisted Consultant for the project;

WHEREAS, on 28 September 2021, the BAC Secretariat sent notice to Global-Link Exhibitions Specialist, Inc., informing of its eligibility for the project;

WHEREAS, Global-Link Exhibitions Specialist, Inc. attended the Pre-bid Conference scheduled on 5 October 2021 via zoom platform;

WHEREAS, during the submission and opening of technical and financial proposals, Global-Link Exhibitions Specialist, Inc. submitted its two envelopes containing the technical and financial proposals;

WHEREAS, pursuant to Sections 33.2.1.b and 33.2.2 of the 2016 Revised IRR of RA 9184, the BAC-TWG conducted a quality cost-based evaluation on the technical and financial proposals of Global-Link Exhibitions Specialist, Inc.;

WHEREAS, pursuant to approved BAC Resolution No. 104, Series of 2021, Global-Link Exhibitions Specialist, Inc. was declared as Single Rated Bidder;

WHEREAS, on 04 November 2021, the BAC negotiated with Global-Link Exhibitions Specialist, Inc. pursuant to Section 33.2.5 of the 2016 Revised IRR of RA 9184;

WHEREAS, the BAC-TWG conducted post-qualification on all the documents submitted by Global-Link Exhibitions Specialist, Inc.;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Global-Link Exhibitions Specialist, Inc., its bid has been found to be responsive;


NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
