**DECLARING THE COMPETITIVE BIDDING FOR THE
PROJECT "PROCUREMENT OF FUEL (GASOLINE AND DIESEL)
AND OIL/LUBRICANT THROUGH FLEET CARD FOR THE DEPARTMENT
OF LABOR AND EMPLOYMENT - CENTRAL OFFICE MOTOR VEHICLES
FOR ONE (1) YEAR" A FAILURE**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱4,266,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 11 October 2021 to 04 November 2021;

WHEREAS, the said project is included in the 2022 FY Indicative Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference which was scheduled on 19 October 2021 was attended by lone prospective bidder Petron Corporation;

WHEREAS, in response to the advertisement, no prospective bidder purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 11 October 2021 to 04 November;


WHEREAS, no prospective bidder attended the scheduled submission and opening of bids which was scheduled on 04 November 2021;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare the competitive bidding a "**failure**" in view of no prospective bidder purchased/submitted bids for the project;
- b. To recommend that a re-bidding be conducted; and
- c. To recommend for approval by the DOLE Secretary the foregoing findings.


