CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of NOV 22 2021, 2021 by and between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **CONVERGE INFORMATION AND COMMUNICATIONS TECHNOLOGY SOLUTIONS, INC.** with office address at Reliance Center, Annex 1, 99 E. Rodriguez Jr. Avenue, Bo. Ugong, Pasig City represented by its **Industry Manager, MS. EVANGELINE E. AQUINO**, hereinafter called the “**Service Provider**”.

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, viz., for the Renewal of the Contract for the **Bureau of Workers with Special Concerns** project “**Subscription of 30 Mbps Internet Leased Line Connection for One (1) Year through Fiber Optic Line**” and the **DOLE** has accepted a total Bid for **Three Hundred Ninety-Nine Thousand Nine Hundred Ninety-Six Pesos only (₱399,996.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General Conditions of Contract;
 - iv. Special Conditions of Contract;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents / statements submitted;

Bid form including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Notice of Award of Contract and Bidder's conforme thereto;
 - d. Performance Security; and

- e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice To Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Three Hundred Ninety-Nine Thousand Nine Hundred Ninety-Six Pesos only (P399,996.00)** or such other sums as may be ascertained, the **Service Provider** agrees to provide Renewal of Contract Agreement for the **Bureau of Workers with Special Concerns** project **“Subscription of 30 Mbps Internet Leased Line Connection for One (1) Year through Fiber Optic Line”** in accordance with its Bid.
4. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




