CONTRACT AGREEMENT

NOV 15 2021

THIS AGREEMENT, made this _____ day of _____, 2021 by and between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **EASTERN TELECOMMUNICATIONS PHILIPPINES, INC.** with office address at Telecoms Plaza, 316 Gil J. Puyat Avenue, Salcedo Village, Makati City, Metro Manila represented by its **Sales Head, MR. MICHAEL S. CASTAÑEDA**, hereinafter called the “**Service Provider**”.

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, viz., for the Renewal of the Contract for the project “**Subscription of 30 Mbps Internet Leased Line Connection via Fiber Optic Cable for Public Employment Service Office (PESO) Portal for the Bureau of Local Employment**” and the **DOLE** has accepted a total Bid for **One Hundred Thirty-Four Thousand Four Hundred Pesos only (₱134,400.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General Conditions of Contract;
 - iv. Special Conditions of Contract;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents / statements submitted;

Bid form including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Notice of Award of Contract and Bidder's conforme thereto;
 - d. Performance Security; and


- e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice To Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **One Hundred Thirty-Four Thousand Four Hundred Pesos only (₱134,400.00)** or such other sums as may be ascertained, the Service Provider agrees to provide the project **“Subscription of 30 Mbps Internet Leased Line Connection via Fiber Optic Cable for Public Employment Service Office (PESO) Portal for the Bureau of Local Employment”** in accordance with its Bid.
4. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
