**DECLARING PHILSTAR DAILY INC. AS THE THIRD
 LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE
 PROJECT "NEWSPAPER PUBLICATION OF THE DOLE 88TH
 ANNIVERSARY ADVERTORIAL SUPPLEMENT"**

WHEREAS, the Department of Labor and Employment (DOLE), through the Information and Publication Service (IPS), requisitioned for the project "Newspaper Publication of the DOLE 88th Anniversary Advertorial Supplement" with a total Approved Budget for the Contract of ₱400,000.00;

WHEREAS, pursuant to approved BAC Resolution No. 067, Series of 2021, the BAC recommended Negotiated Procurement under Section 53 of the 2016 Revised IRR of RA 9184 specifically under Section 53.6 – Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services as the method of procurement for the abovementioned project;

WHEREAS, based on the canvass made by IPS, four (4) publications, namely: (1) BusinessWorld Publishing Corporation (BusinessWorld); (2) The Manila Times (Manila Times); (3) PhilStar Daily Inc. (The Philippine Star); and (4) Manila Standard Publishing, Inc. (Manila Standard) submitted its price proposals and is summarized in the Market Study attached as Annex A;

WHEREAS, based on the Market Study, Philstar Daily Inc. submitted the third lowest quotation;

WHEREAS, Justifications submitted by IPS, PhilStar Daily Inc. has wide readership and among the widely circulated newspaper in the Philippines compared with Manila Times and BusinessWorld. PhilStar Daily Inc. is one of the top three (3) major broadsheets in the country and most trusted sources broadsheets which complied the minimum requirements in the technical specifications.

WHEREAS, PhilStar Daily Inc. submitted its financial and eligibility documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by PhilStar Daily Inc. its bid has been found to be responsive;

WHEREAS, based on the Market Study and the Justification submitted by IPS, Philstar Daily, Inc., is the publisher that could undertake the project at more advantageous terms.

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED**:

- a. To award the project **“Newspaper Publication of the DOLE 88th Anniversary Advertorial Supplement”**; to **PhilStar Daily Inc.**; and
- b. To recommend for approval by the DOLE Undersecretary the foregoing findings.


