**DECLARING GILCOR PRINTING PRESS AS THE LOWEST CALCULATED  
 AND RESPONSIVE BIDDER FOR THE PROJECT "PRINTING OF KABUHAYAN  
 AWARDS COFFEE TABLE BOOK" OF THE BUREAU OF WORKERS WITH  
 SPECIAL CONCERNS**

**WHEREAS**, the Department of Labor and Employment (DOLE), thru the Bureau of Workers with Special Concerns (BWSC), requisitioned for the printing of five hundred (500) copies of Kabuhayan Awards Coffee Table Book with a total Approved Budget for the Contract of ₱ 200,000.00;

**WHEREAS**, the BAC recommended Small Value Procurement as the method of procurement to be adopted for the above-mentioned project as per approved BAC Resolution No. 087, Series of 2021;

**WHEREAS**, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government e-Procurement System (PhilGEPS) and DOLE websites from 02 to 06 October 2021;

**WHEREAS**, in response to the advertisement, nine (9) bidders, namely: (1) Gilcor Printing Press; (2) Erzalan Printing Press; (3) Regencia Printing Services; (4) VJ Graphic Arts, Inc.; (5) Innovation Printshoppe, Inc.; (6) New Age Graphics, Inc.; (7) Color1Digital, Inc.; (8) Veraliz Marketing; and (9) G.A Printing, Inc. submitted their bid proposals before the deadline for the submission and receipt of bids;

**WHEREAS**, the BAC-Technical Working Group (TWG) in its Abstract of Price Quotations examined and evaluated the bid proposals of the nine (9) bidders, to wit:

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Gilcor Printing Press, its bid has been found to be responsive;

**NOW, THEREFORE**, for and in consideration of the foregoing, we, the members of the Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **Gilcor Printing Press** as the Lowest Calculated and Responsive Bidder for the project "Printing of Kabuhayan Awards Coffee Table" of the Bureau of Workers with Special Concerns";
- b) To award the contract of the project "**Printing of Kabuhayan Awards Coffee Table**" to Gilcor Printing Press at a total contract price of **₱114,000.00**; and
- c) To recommend for approval by the DOLE Undersecretary the foregoing findings.




