**DECLARING VJ GRAPHIC ARTS, INC. AS THE LOWEST
CALCULATED AND RESPONSIVE BIDDER FOR THE BUREAU
OF LOCAL EMPLOYMENT PROJECT "PRINTING OF 20TH PESO
MILESTONE COFFEE TABLE BOOK"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱1,000,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises 08 October 2021 to 04 November 2021;

WHEREAS, said project is included in the FY 2021 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference which was scheduled on 19 October 2021 was attended by four (4) bidders namely: (1) Transprint Corporation; (2) VJ Graphic Arts, Inc.; (3) Tanjer Enterprises; and (4) Cover and Pages Corporation;

WHEREAS, Supplemental/Bid Bulletin was issued to amend and clarify some provisions originally indicated in the Bidding Documents;

WHEREAS, in response to the advertisement, three (3) bidders namely: (1) Gilcor Printing Press; (2) VJ Graphic Arts, Inc.; and (3) Cover and Pages Corporation purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 03 - 04 November 2021;

WHEREAS, the submission and opening of bids which was scheduled on 04 November 2021 was attended by (3) bidders namely: (1) Gilcor Printing Press; (2) VJ Graphic Arts, Inc. and (3) Cover and Pages Corporation. Said bidders submitted their technical and financial envelopes. After preliminary examination, the technical proposals of Gilcor Printing Press, VJ Graphic Arts, Inc. and Cover and Pages Corporation were rated as "**passed**" hence, the BAC opened their financial envelopes which were also rated as "**passed**";

WHEREAS, the BAC - TWG in its bid evaluation report dated 08 November 2021 as duly concurred by the members of the BAC, examined and evaluated the bid proposals of Gilcor Printing Press, VJ Graphic Arts, Inc. and Cover and Pages Corporation;

WHEREAS, based on the foregoing evaluation by the TWG, the three bidders Gilcor Printing Press, VJ Graphic Arts, Inc. and Cover and Pages Corporation complied with the mandatory minimum technical specifications and of the three bidders Gilcor Printing Press quoted the lowest bid amount for the said project; was declared as the Lowest Calculated Bidder per BAC Resolution No. 124, Series of 2021;

WHEREAS, upon Client Verification of the Completed Contracts of Gilcor Printing Press, it was found out that its bid is "**Non-Responsive**" due to its unsatisfactory performance with its previous completed contract with the Department particularly the project "**Printing of 20th PESO Milestone Coffee Table**" for the year 2020 and thus, declared post-disqualified;

WHEREAS, BAC Secretariat sent a letter of Post-Disqualification to Gilcor Printing Press as no Motion for Reconsideration was received by the BAC;

WHEREAS, BAC Secretariat sent a letter to VJ Graphic Arts, Inc. requesting for submission of post-qualification documents;

WHEREAS, VJ Graphic Arts, Inc. submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by VJ Graphic Arts, Inc. its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **VJ Graphic Arts, Inc.** as the **Lowest Calculated and Responsive Bidder** for Lot 2 (**International**) of the **Bureau of Local Employment** project "**Printing of 20th PESO Milestone Coffee Table Book**";
- b. To award the procurement of the project "**Printing of 20th PESO Milestone Coffee Table Book**" for the **Bureau of Local Employment** project to VJ Graphic Arts, Inc. as the **Lowest Calculated and Responsive Bidder** for Lot 2 (**International**); and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.




