The Department of Labor and Employment (DOLE), through the FY 2021 General Appropriations Act intends to apply the sum of ₱350,000.00 being the total Approved Budget for the Contract (ABC) to payments under the contract for the project **Supply and Delivery of One (1) unit Heavy Duty PVC/Tarpaulin Printer and One (1) unit Heavy Duty Labeling/Sticker Printer**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

*** If the prospective bidder/s opted to bid for Lots 1, and 2, they can save in the cost of the bidding documents.


2. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. The schedule of bidding activities is as follows:

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. Prospective Bidders may obtain further information from DOLE and inspect the Bidding Documents at the address given below during office hours.
6. The complete set of Bidding Documents may be purchased at the DOLE BAC Secretariat (see address below) upon payment of price of bid documents indicated above. The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) (www.philgeps.gov.ph) and DOLE (www.dole.gov.ph) provided that Bidders shall pay the price not later than the submission of their bids.
7. All interested bidders shall be allowed to attend and participate in the discussion during the Pre-bid Conference to be held via Zoom platform. The Zoom link will be provided by the BAC Secretariat prior to the schedule of the conference (please see BAC Secretariat contact information below).
8. Bids must be duly received by the BAC Secretariat through manual submission at the DOLE – BAC Secretariat office (see address below) on or before the deadline.
9. The Submission and Opening of Bids shall be held at the LGLC, 2nd Floor, Blas F. Ople Hall (formerly DOLE Executive Bldg.), San Jose Street, Intramuros, Manila. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity. Late bids shall not be accepted.

10. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
11. The DOLE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
