**DECLARING AVID SALES CORPORATION AS THE SINGLE CALCULATED
AND RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY AND DELIVERY
OF 88 PIECES WIRELESS SPORTS HEADPHONES AND
88 PIECES TWS EARBUDS"**

WHEREAS, the Department of Labor and Employment (DOLE), through the Bureau of Local Employment (BLE), requisitioned the "Supply and Delivery of 88 pieces Wireless Sports Headphones and 88 pieces TWS Earbuds" with a total Approved Budget for the Contract of ₱203,575.68;

WHEREAS, the said activity is included in the 2021 Annual Procurement Plan of the Department;

WHEREAS, DOLE BAC Resolution No. 96, Series of 2021 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 19 October 2021;

WHEREAS, DOLE advertised the Request for Price Quotation for the procurement of the above-mentioned project in the DOLE Website, and Philippine Government E-Procurement System (PhilGEPS) from 20 October to 25 October 2021;

WHEREAS, in response to the advertisement, two (2) bidders, namely: 1) Avid Sales Corporation, and 2) MCSA Marketing submitted Bid Proposals on the opening of bids scheduled on 25 October 2021;

WHEREAS, the BAC-TWG recommended Avid Sales Corporation as the Lowest Calculated Bidder based on the Abstract of Price Quotations and was declared **responsive** as indicated in the post-qualification report under small value procurement;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the DOLE BAC hereby resolve as it is hereby **RESOLVED**:




