**DECLARING POWER HOUSE PEST CONTROL SERVICES AS
THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE
ADMINISTRATIVE SERVICE'S PROJECT "PROVISION OF TERMITE AND PEST
CONTROL SERVICES FOR A PERIOD OF ONE (1) YEAR IN THE DOLE-CENTRAL
OFFICE"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱410,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 29 November 2021 to 21 December 2021;

WHEREAS, said project is included in the FY 2022 Indicative Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference on 9 December 2021 attended by Power House Pest Control Services and D-Three Pest Management Services;

WHEREAS, in response to the advertisement, two (2) bidders namely: (1) D-Three Pest Management Services; and (2) Power House Pest Control Services purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 1 – 7 December 2021;

WHEREAS, the submission and opening of bids which was scheduled on 21 December 2021 was attended by two (2) prospective bidders namely: (1) D-Three Pest Management Services; and (2) Power House Pest Control Services and submitted their technical and financial envelopes. After preliminary examination, the technical proposals of D-Three Pest Management Services and Power House Pest Control Services were rated as "**passed**" hence, the BAC opened their financial envelopes which were also rated as "**passed**";

WHEREAS, the BAC - TWG in its bid evaluation report dated 22 December 2021 as duly concurred by the members of the BAC, examined and evaluated the bid proposals of D-Three Pest Management Services and Power House Pest Control Services Power;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, D-Three Pest Management Services and Power House Pest Control Services complied with the mandatory minimum technical specifications of the

said project. Moreover, Power House Pest Control Services was declared as Lowest Calculated Bidder per BAC Resolution No. 165, Series of 2021;

WHEREAS, BAC Secretariat sent a letter to Power House Pest Control Services requesting for submission of post-qualification documents;

WHEREAS, Power House Pest Control Services submitted additional documents for post-qualification;

WHEREAS, the BAC - TWG conducted post-qualification of Power House Pest Control Services. Upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Power House Pest Control Services its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Power House Pest Control Services** as the **Lowest Calculated and Responsive Bidder** for the **Administrative Service's** project "**Provision of Termite and Pest Control Services for a Period of One (1) Year in the DOLE-Central Office**";
- b. To award the procurement of the project "**Provision of Termite and Pest Control Services for a Period of One (1) Year in the DOLE-Central Office**" for the **Administrative Service's** to **Power House Pest Control Services** as the **Lowest Calculated and Responsive Bidder**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
