**DECLARING VJ GRAPHIC ARTS, INC. AS THE LOWEST CALCULATED
AND RESPONSIVE BIDDER FOR THE PROJECT "PRINTING OF
JOBSFIT COVID-19 LABOR MARKET INFORMATION REPORT:
THE ROAD TO RECOVERY"**

WHEREAS, the Department of Labor and Employment (DOLE), through the Bureau of Local Employment (BLE), requisitioned the "Printing of JobsFit COVID-19 Labor Market Information Report: The Road to Recovery" with a total Approved Budget for the Contract of ₱250,000.00;

WHEREAS, the said activity is included in the FY 2021 Annual Procurement Plan of the Department;

WHEREAS, DOLE BAC Resolution No. 128, Series of 2021 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 26 November 2021;

WHEREAS, DOLE advertised the Request for Price Quotation for the procurement of the above-mentioned project in the DOLE Website, and Philippine Government E-Procurement System (PhilGEPS) from 02 December to 06 December 2021;

WHEREAS, in response to the advertisement, six (6) bidders, namely: 1) VJ Graphic Arts, Inc. 2) Erzalan Printing Press, 3) Metrocolor Corp., 4) Innovation Printshoppe, Inc., 5) Gilcor Printing Press, and 6) GA Printing, Inc. submitted Bid Proposals on the opening of bids scheduled on 06 December 2021;

WHEREAS, the BAC-TWG recommended VJ Graphic Arts, Inc. as the Lowest Calculated Bidder based on the Abstract of Price Quotations and was declared **responsive** as indicated in the post-qualification report under small value procurement;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the DOLE BAC hereby resolve as it is hereby **RESOLVED**:

- a. To declare **VJ Graphic Arts, Inc.** as the Lowest Calculated and Responsive Bidder for the project "Printing of Jobsfit COVID-19 Labor Market Information Report: Road to Recovery";
- b. To award the "Printing of Jobsfit COVID-19 Labor Market Information Report: Road to Recovery" to **VJ Graphic Arts, Inc.**; and

- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.




