**DECLARING RIZAL PARK HOTEL AS THE HIGHEST RATED VENUE
 PROVIDER FOR THE CONDUCT OF STAKEHOLDERS' NIGHT
 AT THE 88TH DOLE ANNIVERSARY**

WHEREAS, the Department of Labor and Employment (DOLE, thru the Bureau of Labor Relations (BLR) requisitioned for the lease of venue for the conduct of the Stakeholders' Night at the 88th DOLE Anniversary on 06 December 2021 in Metro Manila to be participated by labor and employer representatives, media partners, DOLE officials, and other development partners with a total Approved Budget for the Contract of ₱375,000.00;

WHEREAS, the DOLE Bids and Awards Committee (DOLE-BAC) is guided by Appendix H of the 2016 Revised IRR of RA 9184 (Consolidated Guidelines for the Alternative Methods of Procurement) with the following relevant provisions, among others:

Section V (D.9.c.ii.a) – The BAC shall send the Request For Quotation (RFQ) to at least three (3) venues within the vicinity of the selected location. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

Section V (D.9.c.ii.b) – The venue being offered by the Lessor with the Lowest Calculated Quotation shall then be rated in accordance with the technical specifications prepared pursuant to Appendix B of this Guidelines. Compliance rating with technical specifications may be conducted through ocular inspection, interviews or other forms of due diligence;

WHEREAS, the DOLE - BAC delegated the canvass of the venue from known venue providers in Metro Manila to BLR for the abovementioned event;

WHEREAS, based on the canvass made by BLR, three (3) venue providers in Metro Manila, namely: (1) Rizal Park Hotel, (2) The Diamond Hotel, and (3) The Manila Hotel

submitted their price proposals and is summarized in the Abstract for Price Quotations attached as Annex "A";

WHEREAS, Annex "B" entitled "Table of Rating Factors for Lease of Venue" prepared by BLR showed that the rating of Rizal Park Hotel on four (4) factors is the highest among the three venue providers, as shown below:

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED** that:


- a. The canvass made and the evaluation conducted by BLR shall be adopted by the BAC;
- b. To award the said activity to Rizal Park Hotel because it garnered the highest rating of **97.70%**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
