**DECLARING THE SECOND FAILURE OF BIDDING FOR THE  
BUREAU OF LOCAL EMPLOYMENT PROJECT "SUPPLY AND DELIVERY  
OF VARIOUS ADVOCACY MATERIALS FOR NERS 1 MILLION JOBS FOR 2021"**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱498,600.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 16 November 2021 to 07 December 2021;

**WHEREAS**, the said project is included in the 2021 Annual Procurement Plan of the Department;

**WHEREAS**, no prospective bidder attended the Pre-bid Conference scheduled on 23 November 2021 which was moved on 02 December 2021;

**WHEREAS**, in response to the advertisement, no prospective bidder purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 16 November 2021 to 07 December 2021;

**WHEREAS**, no prospective bidder attended during the submission and opening of bids scheduled on 07 December 2021 which was likewise moved on 14 December 2021;

**NOW, THEREFORE**, for and in consideration of the foregoing, We, the members of the Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare the competitive bidding a "**failure**" in view of no prospective bidder purchased/submitted bids for the project;
- b. To recommend that a Negotiated Procurement through two-failed biddings be conducted; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.




