## CONTRACT AGREEMENT

THIS AGREEMENT, made this \_\_\_ day of 09 FEB 2022, 2022 between **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, corner Muralla and General Luna Streets, Intramuros, Manila, represented by **UNDERSECRETARY RENATO L. EBARLE**, hereinafter called the "DOLE" and **SERVICIO FILIPINO, INC.** with office address at 105 West Ave., Quezon City, represented by its **Business Development Manager, MR. ERWIN L. ABENOJA**, hereinafter called the "Consultant".

**WHEREAS**, the DOLE invited Bids for certain goods and ancillary services, viz., "Consultation Services for the Development of the Career Information Pamphlets (CIPs) on Emerging Occupations" and the DOLE has accepted a total Bid for **Four Hundred Ninety-Eight Thousand Pesos only (₱498,000.00)** hereinafter called the "Contract Price".

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Terms of Reference (Including Annexes A, B and C)
  - (c) Request for Expression of Interest;
  - (d) Instructions to Bidders;
  - (e) Bid Data Sheet;
  - (f) Bid forms (Financial Proposals), including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (g) Eligibility and Technical requirements, documents and/or statements;
  - (h) Performance Security;
  - (i) Notice of Award of Contract and the Bidder's conforme thereto;

(j) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the **DOLE** to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the DOLE to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.

4. The **DOLE** hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.






