**DECLARING SECOND FAILURE OF BIDDING FOR THE PROJECT
“ENGAGEMENT OF TRAINING INSTITUTION/PROVIDER FOR THE
CONDUCT OF ONLINE TRAININGS ON ISO 9001:2015 QUALITY
MANAGEMENT SYSTEM (QMS) FOR CY 2022”**

WHEREAS, the Department of Labor and Employment (DOLE) re-advertised the Invitation to Bid for the competitive bidding of the project “Engagement of Training Institution/Provider for the Conduct of Online Trainings on ISO 9001:2015 Quality Management System (QMS) for CY 2022” with an Approved Budget for the Contract (ABC) of ₱452,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE’s premises from 05 February 2022 to 01 March 2022;

WHEREAS, said project is included in the approved Fiscal Year (FY) 2022 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference via zoom platform scheduled on 15 February 2022 was attended by Synergized Macro Solutions, Inc. (SMS), and BSI Group Philippines, Inc.;

WHEREAS, in response to the advertisement, only BSI Group Philippines, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (BAC) Secretariat;

WHEREAS, the submission and opening of bids scheduled on 01 March 2022, only BSI Group Philippines, Inc. submitted its technical and financial envelopes. Upon opening of the submitted envelopes the BAC - Technical Working Group (TWG) rated it as “**failed**” due to failure to comply with Instruction to Bidders particularly with Section 15 which requires bidder to submit one (1) original and one (1) duplicate copy of the first and second components of its bid.;

WHEREAS, the BAC instructed the BAC Secretariat to inform the bidder that the bid submitted was declared not responsive and thus failed;

WHEREAS, on 02 March 2022, the BAC through the BAC Secretariat issued a letter to BSI Group Philippines, Inc. to inform them of the failure in bidding;


NOW, THEREFORE, for and in consideration of the foregoing, we, the members of the DOLE BAC, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare the re-bidding a "failure" in view of non-compliance with Instruction to Bidders particularly with Section 15 which requires bidder to submit one (1) original and one (1) duplicate copy of the first and second components of its bid;
- b. To recommend that a Negotiated Procurement through two-failed biddings be conducted ; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings
