DECLARING LSERV CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE RE-BIDDING OF THE PROJECT “OUTSOURCING OF MANPOWER SERVICES FOR THE DOLE – CENTRAL OFFICE FOR CY 2022”

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the re-bidding of the abovementioned project with an Approved Budget for the Contract (ABC) of ₱ 38,670,151.92 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE’s premises from 16 November 2021 to 07 December 2021;

WHEREAS, said project is included in the approved Indicative FY 2022 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference originally scheduled on 23 November 2021 was rescheduled to 02 December 2021 and was attended by the following bidders: (1) Trademaster Resources Corp.; (2) Temps and Staffers, Inc.; and (3) LSERV Corporation;

WHEREAS, only LSERV Corporation purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

WHEREAS, the schedule of the submission and opening of bids was moved from 07 December 2021 to 14 December 2021;

WHEREAS, during the submission and opening of bids, only LSERV Corporation submitted its technical and financial envelopes. Upon eligibility check, the technical component of the lone bidder was rated as “**passed**”. Hence, the BAC-Technical Working Group (TWG) opened the financial envelope which was likewise found to be compliant and recommended for bid evaluation. The BAC approved the TWG’s recommendation and instructed the TWG to conduct immediate bid evaluation;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC TWG, LSERV Corporation was declared as the Single Calculated Bidder per BAC Resolution No. 160, Series of 2021;

WHEREAS, the BAC Secretariat sent a notice to the lone bidder requesting for submission of post-qualification documents;

WHEREAS, on 21 December 2021, LSERV Corporation submitted their post-qualification documents;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by LSERV Corporation, its bid has been found to be responsive;


NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- b. To award the project “**Outsourcing of Manpower Services for the DOLE – Central Office for CY 2022**” to LSERV Corporation at a contract price of **₱37,716,382.56**; and
- c. To recommend for approval by the DOLE Secretary the foregoing findings.
