RECOMMENDING AGENCY-TO-AGENCY UNDER NEGOTIATED PROCUREMENT AS THE METHOD OF PROCUREMENT FOR THE RENEWAL OF THE SUBSCRIPTION OF WEB HOSTING SERVICE FOR ALIEN EMPLOYMENT PERMIT MONITORING SYSTEM FOR ONE (1) YEAR

WHEREAS, the Department of Labor and Employment (DOLE), through the Bureau of Local Employment (BLE), requisitioned for the Renewal of the Subscription of Web Hosting Service for Alien Employment Permit (AEP) Monitoring System for One (1) Year with an Approved Budget for the Contract of ₱2,000,000.00;

WHEREAS, said project is included in the approved FY 2022 Annual Procurement Plan of the Department;

WHEREAS, Section 53.5 of the 2016 Revised Implementing Rules and Regulations of Republic Act (RA) 9184, "Agency-to-Agency" under Negotiated Procurement, as an alternative method of procurement provides that:

"Procurement of Goods, Infrastructure Projects, and Consulting Services, from another agency of the Government of the Philippines (GOP), such as the Department of Budget and Management – Procurement Service (DBM-PS)..."

WHEREAS, the DOLE-BAC is recommending "Agency to Agency" under Negotiated Procurement as the method of procurement for the Renewal of the Subscription of Web Hosting Service for Alien Employment Permit (AEP) for One (1) Year with the DBM-PS as the identified GOP agency which have already conducted various bidding projects in their Inter-Agency Bids and Awards Committee;

NOW THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE-Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To recommend Agency to Agency under Negotiated Procurement as the method of procurement to be adopted for the Renewal of the Subscription of Web Hosting Service for Alien Employment Permit (AEP) for One (1) Year; and
- b) To recommend for approval by the DOLE Secretary the foregoing findings.






