**DECLARING PISHON INDUSTRIES INCORPORATED AS THE LOWEST  
CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY  
AND DELIVERY OF FIVE (5) GALLON PURIFIED DRINKING WATER  
FOR OFFICIALS AND EMPLOYEES OF THE DOLE CENTRAL OFFICE  
FOR A PERIOD OF ONE (1) YEAR"- RE-BIDDING**

**WHEREAS**, the Department of Labor and Employment (DOLE) re-advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱600,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website and conspicuous places at the DOLE's premises from 24 December 2021 to 18 January 2022;

**WHEREAS**, said project is included in the approved Fiscal Year (FY) 2022 Annual Procurement Plan of the Department;

**WHEREAS**, the Pre-bid Conference via zoom platform scheduled on 04 January 2022, was attended by three (3) bidders, namely: 1) Aquasure Water Trading, 2) Pishon Industries, Inc. and 3) Golden Tiger Water Refilling Station;

**WHEREAS**, in response to the advertisement, three (3) bidders, namely: 1) Pishon Industries Incorporated, 2) Aquasure Water Trading and 3) Golder Tiger Water Refilling Station purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

**WHEREAS**, the submission and opening of bids scheduled on 18 January 2022, was attended by three (3) bidders, namely: 1) Pishon Industries Incorporated, 2) Aquasure Water Trading, and 3) Golder Tiger Water Refilling Station. Said bidders submitted their technical and financial envelopes. Upon eligibility check Golden Tiger Water Refilling Station was rated as **"failed"** due to submission of Statement of Single Largest Completed Contract which is not in conformity with the prescribed GPPB form. Two (2) bidders, namely: 1) Aquasure Water Trading, and 2) Pishon Industries, Incorporated were rated as **"passed"** hence, the BAC – Technical Working Group (BAC-TWG) opened the financial envelopes which were likewise found to be compliant and recommended for bid evaluation;

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE BAC Technical Working Group (TWG) on 18 January 2022, Aquasure Water Trading was declared as the Lowest Calculated Bidder per BAC Resolution No. 013, Series of 2022 for the project “**Supply and Delivery of Five (5) Gallon Purified Drinking Water for Officials and Employees of the DOLE Central Office for a Period of One (1) Year**”- *Re-Bidding*;

**WHEREAS**, based on the post-qualification conducted by the DOLE BAC TWG on 28 January 2022, Aquasure Water Trading was declared as Post-Disqualified Bidder per BAC Resolution No. 033, Series of 2022;

**WHEREAS**, on 16 February 2022, the BAC Secretariat sent a notice to the Second Lowest Calculated Bidder, Pishon Industries, Incorporated requesting for submission of post-qualification documents;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **Pishon Industries, Incorporated**, its bid has been found to be responsive;


**NOW, THEREFORE**, for and in consideration of the foregoing, we, the members of the DOLE BAC, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Pishon Industries, Incorporated** as the Lowest Calculated and Responsive Bidder for the project “**Supply and Delivery of Five (5) Gallon Purified Drinking Water for Officials and Employees of the DOLE Central Office for a Period of One (1) Year**”;
- b. To award the project “Supply and Delivery of Five (5) Gallon Purified Drinking Water for Officials and Employees of the DOLE Central Office for a Period of One (1) Year” to **Pishon Industries, Incorporated**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings
