**DECLARING REMAX INTERNATIONAL, INC. AS THE
SINGLE CALCULATED AND RESPONSIVE BIDDER FOR LOTS 1
AND 3 OF THE PLANNING SERVICE PROJECT “SUPPLY AND DELIVERY
OF VARIOUS ICT EQUIPMENT FOR THE DOLE – CENTRAL OFFICE
PRODUCTIVITY”**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the bidding of the project “Supply and Delivery of Various ICT Equipment for the DOLE – Central Office Productivity” with a total Approved Budget for the Contract (ABC) of ₱17,275,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE’s premises from 30 November 2021 to 21 December 2021;

WHEREAS, said project consists of six (6) lots and is included in the approved Indicative FY 2022 Annual Procurement Plan of the Department, to wit:

WHEREAS, the Pre-bid Conference scheduled on 07 December 2021 was rescheduled to 09 December 2021 and was attended by five (5) bidders, namely: (1) Remax International, Inc.; (2) Pronet Systems Integrated Network Solution, Inc.; (3) Digi-Specs I.T. Corp.; (4) Solid Business Machine Center, Inc.; and (5) Infobahn Communications, Inc.;

WHEREAS, seven (7) bidders purchased the bidding documents from the DOLE – Central Office - Bids and Awards Committee (DOLE – CO - BAC) Secretariat, to wit;

WHEREAS, Supplemental/Bid Bulletin No. 23, Series of 2021 was issued to clarify or amend some provisions originally indicated in the Bidding Documents specifically on the specifications under Section VI – Schedule of Requirements and Section VII – Technical Specifications;

WHEREAS, the schedule of the submission and opening of bids has been moved from 21 December 2021 to 28 December 2021;

WHEREAS, during the submission and opening of bids, seven (7) bidders, namely: 1) Remax International, Inc.; (2) Pronet Systems Integrated Network Solution, Inc.; (3) Digi-Specs I.T. Corp.; (4) Solid Business Machine Center, Inc.; (5) Infobahn Communications, Inc.; (6) DCI Int'l IT Solutions & Services Corp. and (7) Accel Prime Technologies, Inc. (APTI) submitted their technical and financial envelopes. Upon eligibility check, the technical components of the seven (7) bidders were rated as “**passed**”. Hence, the BAC-Technical Working Group (TWG) opened the financial envelopes which were likewise found to be compliant and recommended for bid evaluation. The BAC approved the TWG’s recommendation and instructed the TWG to conduct immediate bid evaluation;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC TWG, Remax International, Inc. was declared as the Single Calculated Bidder for Lots 1 and 3 of the above-mentioned project per BAC Resolution No. 002, Series of 2022;

WHEREAS, the DOLE - CO - BAC declared Remax International, Inc., Infobahn Communications, Inc., Solid Business Machine Center, Inc. and Pronet Systems Integrated Network Solution, Inc. were declared as the Lowest Calculated Bidders for Lots 2, 4, 5 and 6 respectively as per BAC Resolution No. 003, Series of 2022;

WHEREAS, 11 January 2022, the BAC Secretariat sent a notice to Remax International, Inc. requesting for submission of post-qualification documents;

WHEREAS, on 14 and 18 January 2022, Remax International, Inc. submitted their post-qualification documents;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Remax International, Inc., its bid for Lot 1 and Lot 3 has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Remax International, Inc.** as the Single Calculated and Responsive Bidder for Lot 1 – 50 units Desktop (Branded – Brand New) and Lot 3 – 111 units Laptop (Branded – Brand New) of the project “**Supply and Delivery of Various ICT Equipment for the DOLE – Central Office Productivity**”;
- b. To award Lot 1 – 50 units Desktop (Branded – Brand New) at a contract price of **₱3,837,100.00** and Lot 3 – 111 units Laptop (Branded – Brand New) at a contract price of **₱8,572,086.00** of the project “**Supply and Delivery of Various ICT Equipment for the DOLE – Central Office Productivity** to **Remax International, Inc.**; and
- c. To recommend for approval by the DOLE Secretary the foregoing findings.
