**DECLARING MAROONSTUDIOS, INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR LOT 1 OF THE PLANNING SERVICE PROJECT "ONLINE SUBSCRIPTION OF GOOGLE WORKSPACE AND CLOUDFLARE BUSINESS EDITION AND LICENSE RENEWAL OF FIREWALL FOR ONE (1) YEAR"**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the bidding of the abovementioned project with a total Approved Budget for the Contract (ABC) of ₱2,637,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 11 December 2021 to 04 January 2022;

**WHEREAS**, said project consists of three (3) lots and is included in the approved Indicative FY 2022 Annual Procurement Plan of the Department, to wit:

**WHEREAS**, the Pre-bid Conference scheduled on 21 December 2021 was attended by four (4) bidders, namely: (1) GOCOM Systems and Solutions Corporation; (2) Computrade Tech Philippines; (3) MaroonStudios, Inc.; and (4) Q Software Research Corporation;

**WHEREAS**, two (2) bidders purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat, to wit:

**WHEREAS**, during the submission and opening of bids which was scheduled on 04 January 2022, GOCOM Systems and Solutions Corporation and MaroonStudios, Inc. submitted their technical and financial envelopes. Upon eligibility check, the technical components of the two (2) bidders were rated as “**passed**”. Hence, the BAC-Technical Working Group (TWG) opened the financial envelopes which were likewise found to be compliant and recommended for bid evaluation. The BAC approved the TWG’s recommendation and instructed the TWG to conduct immediate bid evaluation;

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE-BAC TWG, MaroonStudios, Inc. was declared as the Lowest Calculated Bidder for Lot 1 of the above-mentioned project per BAC Resolution No. 004, Series of 2022;

**WHEREAS**, GOCOM Systems and Solutions Corporation was declared as the Single Calculated Bidder for Lots 2 and 3 per BAC Resolution No. 005, Series of 2022;

**WHEREAS**, on 12 January 2022, the BAC Secretariat sent a notice to the two (2) bidders requesting for submission of post-qualification documents;

**WHEREAS**, on 18 January 2022, GOCOM Systems and Solutions Corporation and MaroonStudios, Inc. submitted their post-qualification documents;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the two (2) bidders, their bids have been found to be responsive;

**WHEREAS**, GOCOM Systems and Solutions Corporation was declared as the Single Calculated and Responsive Bidder for Lots 2 and Lot 3 per BAC Resolution No. 023, Series of 2022;

**WHEREAS**, the DOLE – CO – BAC recommended MaroonStudios, Inc. as the Lowest Calculated and Responsive Bidder for Lot 1;

**NOW, THEREFORE, We**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **MaroonStudios, Inc.** as the **Lowest Calculated and Responsive Bidder** for Lot 1 – Subscription of License for Google Workspace (Enterprise Starter) for One (1) Year of the project “**Online Subscription of Google Workspace and Cloudflare Business Edition and License Renewal of Firewall for One (1) Year**”;
- b. To award Lot 1 – Subscription of License for Google Workspace (Enterprise Starter) for One (1) Year at a contract price of **₱1,765,146.00** of the project “**Online Subscription of Google Workspace and Cloudflare Business Edition and License Renewal of Firewall for One (1) Year** to **MaroonStudios, Inc.**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.


