CONTRACT AGREEMENT

THIS AGREEMENT, made this **MAR 29 2022** day of _____, 2022 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, corner Muralla and General Luna Streets, Intramuros, Manila, represented by **UNDERSECRETARY CLARO A. ARELLANO**, hereinafter called the “**DOLE**” and **EASTERN TELECOMMUNICATIONS PHILIPPINES, INC.**, with office address at Telecoms Plaza, 316 Gil J. Puyat Avenue Salcedo Village, Makati City represented by its Sales Head, **MR. MICHAEL S. CASTAÑEDA**, hereinafter called the “**SERVICE PROVIDER**”.

WHEREAS, the DOLE invited Bids for certain goods and ancillary services, viz., “**Subscription of 40 Mbps Internet Leased Line via Fiber Optic Cable for a Period of One (1) Year for International Labor Affairs Bureau**” and the DOLE has accepted a Bid for **Three Hundred Thirty-Six Thousand Pesos only (P336,000.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Terms of Reference;
 - ii. Supplemental/Bid Bulletin;
 - iii. Schedule of Requirements;
 - iv. Technical Specifications; and
 - v. General and Special Conditions of Contract
- ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract, and the Bidder’s conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional**

contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Three Hundred Thirty-Six Thousand Pesos only (P336,000.00)** or such other sums as may be ascertained, **EASTERN TELECOMMUNICATIONS PHILIPPINES, INC.** agrees to deliver **Subscription of 40 Mbps Internet Leased Line via Fiber Optic Cable for a Period of One (1) Year for International Labor Affairs Bureau** in accordance with its Bid.
4. The DOLE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
