



CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of _____, 2022 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, corner Muralla and General Luna Streets, Intramuros, Manila, represented by **UNDERSECRETARY RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **GOCOM SYSTEMS AND SOLUTIONS CORPORATION**, with office address at Unit 218 Cityland Pioneer Building, Pioneer St., Highways Hills, Mandaluyong City represented by its Sales Director, **MR. GLENN PAUL P. CACANINDIN**, hereinafter called the “**SERVICE PROVIDER**”.

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

 - iii. Technical Specifications;
 - iv. General and Special Conditions of Contract; and
 - v. Purchase Order
- ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract, and the Bidder’s conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional**

contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **One Hundred Ninety-Nine Thousand Pesos only (₱199,000.00)** for Lot 2 and **Two Hundred Forty Thousand Pesos only (₱240,000.00)** for Lot 3 or such other sums as may be ascertained, **GOCOM SYSTEMS AND SOLUTIONS CORPORATION** agrees to deliver **Subscription of Cloudflare Business Edition for One (1) Year** and **Renewal of Fortinet License with Serial Number: FG200D4615804330 for One (1) Year** in accordance with its Bid.
4. The DOLE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






