**DECLARING CEBOOM ENTERPRISES AS THE LOWEST
CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT
“SUPPLY AND DELIVERY OF 687 PIECES 2022 NWMC ADVOCACY SHIRT
WITH PRINT AND 687 PIECES 2022 NWMC ADVOCACY DRAWSTRING POUCH
WITH PRINT”**

WHEREAS, the Department of Labor and Employment (DOLE), through the Human Resource Development Service (HRDS), requisitioned for the project “Supply and Delivery of 687 Pieces 2022 NWMC Advocacy Shirt with Print and 687 Pieces 2022 NWMC Advocacy Drawstring Pouch with Print” with a total Approved Budget for the Contract of ₱329,760.00;

WHEREAS, the BAC Resolution No. 054, Series of 2022 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 16 March 2022;

WHEREAS, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government E-Procurement Systems (PhilGEPS), DOLE website from 17 March 2022 to 21 March 2022;

WHEREAS, in response to the advertisement, three (3) bidders namely; (1) Hanaya Style Trading; (2) Ceboom Enterprises; and (3) Leon Cullen’s Trading submitted its price proposals and is summarized in the Abstract of Price Quotations attached as Annex A, wherein Ceboom Enterprises quoted the lowest bid price;

WHEREAS, based on the Abstract for Price Quotation submitted by BAC-TWG, Ceboom Enterprises complied with the minimum requirements of the end-user and quoted the lowest bid price of the contract for the project “Supply and Delivery of 687 Pieces 2022 NWMC Advocacy Shirt with Print and 687 Pieces 2022 NWMC Advocacy Drawstring Pouch with Print”;

WHEREAS, Ceboom Enterprises submitted its financial and eligibility documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Ceboom Enterprises its bid has been found to be responsive;

WHEREAS, the BAC-Technical Working Group (TWG) recommended, Ceboom Enterprises as the **Lowest Calculated and Responsive Bidder** for the project **“Supply and Delivery of 687 Pieces 2022 NWMC Advocacy Shirt with Print and 687 Pieces 2022 NWMC Advocacy Drawstring Pouch with Print”** based on the Abstract of Price Quotation and was declared **responsive** as indicated in the post-qualification report under Small Value Procurement;


NOW, THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED**:


- a. To declare **Ceboom Enterprises** as the **Lowest Calculated and Responsive Bidder** for the project **“Supply and Delivery of 687 Pieces 2022 NWMC Advocacy Shirt with Print and 687 Pieces 2022 NWMC Advocacy Drawstring Pouch with Print”**;
- b. To award the procurement of the project **“Supply and Delivery of 687 Pieces 2022 NWMC Advocacy Shirt with Print and 687 Pieces 2022 NWMC Advocacy Drawstring Pouch with Print”** to **Ceboom Enterprises** via **Small Value Procurement**, with a total contract price of **Php 252,816.00**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.

RESOLVED, at the DOLE Main Building, Intramuros, Manila, this 23rd day of March 2022.


