RECOMMENDING AGENCY-TO-AGENCY UNDER NEGOTIATED PROCUREMENT AS THE METHOD OF PROCUREMENT FOR THE PROJECT “SUBSCRIPTION OF WEB HOSTING SERVICE FOR ONE (1) YEAR FOR THE DOLE WEBSITES, E-MAIL, AND OFFICE PERFORMANCE COMMITMENT AND REVIEW SYSTEM, AND PREVENTIVE MAINTENANCE SYSTEM”

WHEREAS, the Department of Labor and Employment (DOLE) through the Planning Service (PS), requisitioned for the Subscription of Web Hosting Service for One (1) Year for the DOLE Websites, Electronic Mail (e-mail), Office Performance Commitment and Review System, and Preventive Maintenance System” with an Approved Budget for the Contract of ₱2,500,000.00;

WHEREAS, said project is included in the approved Indicative FY 2022 Annual Procurement Plan of the Department;

WHEREAS, Section 53.5 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, ‘Agency-to-Agency’ under Negotiated Procurement, as an alternative mode of procurement provides that:

“Procurement of Goods, Infrastructure Projects and Consulting Services from another agency of the Government of the Philippines (GOP), such as the Department of Budget and Management - Procurement Service (DBM-PS)

WHEREAS, the DOLE-BAC is recommending ‘Agency-to-Agency’ under Negotiated Procurement as the mode of procurement for the project “*Subscription of Web Hosting Service for One (1) Year for the DOLE Websites, Electronic Mail (e-mail), Office Performance Commitment and Review System, and Preventive Maintenance System*” with the DBM-PS as the identified GOP agency which have already conducted various bidding projects in their Inter-Agency Bids and Awards Committee;

NOW, THEREFORE, for and in consideration of the foregoing, we, the members of the Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To recommend Agency-to-Agency under Negotiated Procurement as the mode of procurement to be adopted for the renewal and top up on the project “*Subscription of Web Hosting Service for One (1) Year for the DOLE Websites, Electronic Mail (e-mail), Office Performance Commitment and Review System, and Preventive Maintenance System*”; and
2. To recommend for approval by the DOLE Secretary the foregoing findings.


