DECLARING KAHUNA HOTEL CAFÉ AND RESTAURANT AS THE HIGHEST-RATED VENUE PROVIDER FOR THE CONDUCT OF BUREAU OF LABOR RELATIONS STRATEGIC PLANNING, GENDER AND DEVELOPMENT ORIENTATION AND ORGANIZATIONAL DEVELOPMENT

WHEREAS, the Department of Labor and Employment (DOLE), thru the Bureau of Labor Relations (BLR), requisitioned the lease of venue for the conduct of Strategic Planning, Gender and Development (GAD) Orientation, and Organizational Development to be held on 19 to 21 May 2022 in La Union with a total Approved Budget for the Contract of ₱264,000.00;

WHEREAS, the DOLE Bids and Awards Committee (DOLE-BAC) is guided by Appendix H of the 2016 Revised IRR of RA 9184 (Consolidated Guidelines for the Alternative Methods of Procurement) with the following relevant provisions, among others:

Section V (D.9.c.ii.a) – The BAC shall send the Request For Quotation (RFQ) to at least three (3) venues within the vicinity of the selected location. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

Section V (D.9.c.ii.b) – The venue being offered by the Lessor with the Lowest Calculated Quotation shall then be rated in accordance with the technical specifications prepared pursuant to Appendix B of this Guidelines. Compliance rating with technical specifications may be conducted through ocular inspection, interviews or other forms of due diligence;

WHEREAS, the DOLE - BAC delegated the canvass of the venue from known venue providers in La Union to BLR for the abovementioned event;

WHEREAS, based on the canvass made by BLR, three (3) venue providers in La Union namely: (1) Kahuna Hotel Café and Restaurant, (2) Awesome Hotel, Inc., and (3) Aureo La Union submitted their price proposals and is summarized in the Abstract for Price Quotations attached as Annex "A";

WHEREAS, Annex "B" entitled "Table of Rating Factors for Lease of Venue" prepared by BLR showed that the rating of Kahuna Hotel Café and Restaurant on four (4) factors is the highest among the three venue providers, as shown below:

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED** that:


- a. The canvass made and the evaluation conducted by BLR shall be adopted by the BAC;
