**DECLARING DIAMZON AND GOPEZ REF AND AIRCONDITIONING INDUSTRIES CO. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT “SUPPLY, DELIVERY AND INSTALLATION OF TWELVE (12) AIRCONDITIONING UNITS INCLUDING REMOVAL OF OLD AND DEFECTIVE UNITS FOR THE BUREAU OF LOCAL EMPLOYMENT”**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the re-bidding of the project “Supply, Delivery and Installation of Twelve (12) Airconditioning Units Including Removal of Old and Defective Units for the Bureau of Local Employment” with an Approved Budget for the Contract (ABC) of ₱3,000,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website and conspicuous places at the DOLE’s premises from 16 November 2021 to 07 December 2021;

**WHEREAS**, said project is included in the approved FY 2021 Annual Procurement Plan of the Department;

**WHEREAS**, the Pre-bid Conference originally scheduled on 23 November 2021 was rescheduled to 02 December 2021 and was attended by KService Trade, Inc. and MJL Enterprises;

**WHEREAS**, Diamzon and Gopez Ref and Airconditioning Industries Co. and MJL Enterprises purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

**WHEREAS**, Supplemental/Bid Bulletin No. 21, Series of 2021 was issued to clarify or amend some provisions originally indicated in the Bidding Documents specifically on the specifications under Section VI – Schedule of Requirements and Section VII – Technical Specifications;

**WHEREAS**, the submission and opening of bids originally scheduled on 07 December 2021 was rescheduled twice, 14 and 21 December 2021 to comply with Sections 22.2 and 29 of the 2016 Revised IRR of RA No. 9184;

**WHEREAS**, during the submission and opening of bids, Diamzon and Gopez Ref and Airconditioning Industries Co. and MJL Enterprises submitted their technical and financial envelopes. Upon eligibility check, the technical component of the two (2) bidders were rated as “**passed**”. Hence, the BAC-Technical Working Group (TWG) opened the financial envelopes of the two (2) eligible bidders which were likewise found to be compliant and recommended for bid evaluation. The BAC approved the TWG’s recommendation and instructed the TWG to conduct immediate bid evaluation;

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE-BAC TWG, Diamzon and Gopez Ref and Airconditioning Industries Co. was declared as the Lowest Calculated Bidder per BAC Resolution No. 170, Series of 2021;

**WHEREAS**, on 04 January 2022, the BAC Secretariat sent a notice to Diamzon and Gopez Ref and Airconditioning Industries Co., requesting for submission of post-qualification documents;

**WHEREAS**, on 05 January 2022, Diamzon and Gopez Ref and Airconditioning Industries Co. submitted their post-qualification documents;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Diamzon and Gopez Ref and Airconditioning Industries Co., its bid has been found to be responsive;

**NOW, THEREFORE, We**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Diamzon and Gopez Ref and Airconditioning Industries Co.** as the Lowest Calculated and Responsive Bidder for the project “**Supply, Delivery and Installation of Twelve (12) Airconditioning Units Including Removal of Old and Defective Units for the Bureau of Local Employment**”;
- b. To award the project “**Supply, Delivery and Installation of Twelve (12) Airconditioning Units Including Removal of Old and Defective Units for the Bureau of Local Employment**” to **Diamzon and Gopez Ref and Airconditioning Industries Co.** at a contract price of **₱2,900,661.25**; and
- c. To recommend for approval by the DOLE Secretary the foregoing findings.
