**DECLARING PLDT INC. AS THE LOWEST CALCULATED AND  
RESPONSIVE BIDDER FOR THE BUREAU OF LOCAL EMPLOYMENT'S  
PROJECT "SUBSCRIPTION OF 80MBPS INTERNET LEASED LINE  
CONNECTION VIA FIBER OPTIC CABLE FOR ONE (1) YEAR"**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the competitive bidding for the Bureau of Local Employment project "Subscription of 80Mbps Internet Leased Line Connection via Fiber Optic Cable for One (1) Year" with an Approved Budget for the Contract (ABC) of ₱960,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 10 March 2022 to 05 April 2022;

**WHEREAS**, said project is included in the FY 2022 Annual Procurement Plan of the Department;

**WHEREAS**, the Pre-bid Conference scheduled on 22 March 2022 was attended by three (3) bidders namely: (1) Philippine Global Communications, Inc.; (2) PLDT Inc.; and (3) Converge Information and Communications Technology Solutions, Inc.;

**WHEREAS**, in response to the advertisement, three (3) prospective bidders namely: (1) PLDT Inc.; (2) Philippine Global Communications, Inc.; and (3) Eastern Telecommunications Philippines, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 04 April 2022 to 05 April 2022;

**WHEREAS**, during the submission and opening of bids scheduled on 05 April 2022, it was attended by three (3) bidders namely: (1) PLDT Inc.; (2) Philippine Global Communications, Inc.; and (3) Eastern Telecommunications Philippines, Inc. The said bidders submitted their technical and financial envelopes. After the conduct of preliminary examination, the technical proposals of PLDT Inc., Philippine Global Communications, Inc. and Eastern Telecommunications Philippines, Inc. were rated as "**passed**". Hence, the BAC opened their financial envelopes which were also rated as "**passed**";

**WHEREAS**, the BAC - TWG in its bid evaluation report dated 08 April 2022 as duly concurred by the members of the BAC, examined and evaluated the bid proposals of PLDT Inc., Philippine Global Communications, Inc. and Eastern Telecommunications Philippines, Inc.;

**WHEREAS**, based on the foregoing evaluation by the TWG, the three bidders complied with the mandatory minimum technical specifications. PLDT Inc. who offered

the lowest bid amount for the said project, was declared as the Lowest Calculated Bidder per BAC Resolution No. 063, Series of 2022;

**WHEREAS**, the BAC Secretariat sent a letter to PLDT Inc. requesting for submission of post-qualification documents;

**WHEREAS**, PLDT Inc. submitted additional documents for post-qualification;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by PLDT Inc. its bid has been found to be responsive;


**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **PLDT Inc.** as the **Lowest Calculated and Responsive Bidder** for the **Bureau of Local Employment's** project "**Subscription of 80Mbps Internet Leased Line Connection via Fiber Optic Cable for One (1) Year**";
- b. To award the procurement of the project "**Subscription of 80Mbps Internet Leased Line Connection via Fiber Optic Cable for One (1) Year**" for the **Bureau of Local Employment** to **PLDT Inc.** as the **Lowest Calculated and Responsive Bidder** at a contract price of **₱275,520.00**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
