**BAC Resolution No. 066
Series of 2022**

**DECLARING ZURBANO PUBLISHING AND PRINTING CORP.
AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR
THE INFORMATION AND PUBLICATION SERVICE'S PROJECT
"PRINTING OF 2022 PHILIPPINE LABOR"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the competitive bidding of the Information and Publication Service's project "**Printing of 2022 Philippine Labor**" with an Approved Budget for the Contract (ABC) of ₱600,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 08 March 2022 to 29 March 2022;

WHEREAS, said project is included in the FY 2022 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference scheduled on 15 March 2022 was attended by five (5) bidders namely: (1) VJ Graphic Arts, Inc.; (2) Innovation Printshoppe Inc.; (3) Velprint Corporation; (4) Zurbano Publishing and Printing Corp.; and (5) Dependable Packaging and Printing House Corp.;

WHEREAS, in response to the advertisement, six (6) bidders namely: (1) Dependable Packaging and Printing House Corp.; (2) Gilcor Printing Press; (3) Cover and Pages Corporation; (4) Innovation Printshoppe Inc.; (5) VJ Graphic Arts, Inc.; and (6) Zurbano Publishing and Printing Corp. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 16 March 2022 to 29 March 2022;

WHEREAS, during the submission and opening of bids on 29 March 2022, it was attended by five (5) bidders namely: (1) Dependable Packaging and Printing House Corp.; (2) Gilcor Printing Press; (3) VJ Graphic Arts, Inc.; (4) Zurbano Publishing and Printing Corp.; and (5) Innovation Printshoppe Inc. Said bidders submitted their technical and financial envelopes;

WHEREAS, after the conduct of preliminary examination, the following bid submissions were rated as "**failed**": (a) Dependable Packaging and Printing House Corp. for submitting only one copy of its technical component and financial component instead of one original and one copy despite the instructions to bidders provided in the Bidding Documents for the project; (b) Gilcor Printing Press for non-compliance with the proper sealing and markings of bid envelope as instructed in the Bidding Documents; and (c) Cover and Pages Corporation for non-compliance with the Government Procurement Policy Board (GPPB) prescribed form of their Single Largest Completed Contract;

WHEREAS, the Technical proposals of VJ Graphic Arts, Inc.; Zurbano Publishing and Printing Corp.; and Innovation Printshoppe Inc. were rated as “**passed**”. Hence, the BAC - TWG opened their financial envelopes which were also rated as “**passed**”;

WHEREAS, Dependable Packaging and Printing House Corp.; Gilcor Printing Press; and Cover and Pages Corporation were informed that they can file a motion for reconsideration within three (3) calendar days but no MR was received by the BAC Secretariat;

WHEREAS, the BAC - TWG in its bid evaluation report dated 01 April 2022 as duly concurred by the members of the BAC, examined and evaluated the bid proposals of Zurbano Publishing and Printing Corp.; Innovation Printshoppe Inc.; and VJ Graphic Arts, Inc.;

WHEREAS, based on the foregoing evaluation by the TWG, the three bidders complied with the mandatory minimum technical specifications. Zurbano Publishing and Printing Corp. offered the lowest bid amount for the said project was declared as the Lowest Calculated Bidder per BAC Resolution No. 060, Series of 2022;

WHEREAS, BAC Secretariat sent a letter to Zurbano Publishing and Printing Corp. requesting for submission of post-qualification documents;

WHEREAS, Zurbano Publishing and Printing Corp. submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Zurbano Publishing and Printing Corp. its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Zurbano Publishing and Printing Corp.** as the **Lowest Calculated and Responsive Bidder** for the **Information and Publication Service’s** project “**Printing of 2022 Philippine Labor**”;
- b. To award the procurement of the project “**Printing of 2022 Philippine Labor**” for the **Information and Publication Service’s** to **Zurbano Publishing and Printing Corp.** as the **Lowest Calculated and Responsive Bidder** at a contract price of **₱423,000.00**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.




