

CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of 27 APR 2022, 2022 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, corner Muralla and General Luna Streets, Intramuros, Manila, represented by **UNDERSECRETARY RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **SOLID BUSINESS MACHINES CENTER, INC.** with office address at Suite 303, Singson Building, Plaza Moraga, Binondo, Manila represented by its Account Manager, **MR. EDMUNDO T. CONDE**, hereinafter called the “**SUPPLIER**”.

WHEREAS, the DOLE invited Bids for certain goods and ancillary services, viz., “**Lot 5 – 20 Units Document Scanner (Branded – Brand New)** of the project “**Supply and Delivery of Various ICT Equipment for the DOLE – Central Office Productivity**” and the DOLE has accepted a Bid for **Lot 5 – Five Hundred Seventy Thousand Pesos only (₱ 570,000.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Purchase Request;
 - ii. Schedule of Requirements;
 - iii. Technical Specifications;
 - iv. General and Special Conditions of Contract; and
 - v. Purchase Order
- ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract, and the Bidder’s conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the

Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


3. In consideration for the sum of **Five Hundred Seventy Thousand Pesos only (₱ 570,000.00)** for Lot 5 or such other sums as may be ascertained, **SOLID BUSINESS MACHINES CENTER, INC.** agrees to **Supply and Deliver Twenty (20) Units Document Scanner (Branded – Brand New)** in accordance with its Bid.
4. The DOLE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




