CONTRACT AGREEMENT

THIS AGREEMENT, made this 20 day of NOV 20 2020, 2022 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, corner Muralla and General Luna Streets, Intramuros, Manila, represented by **SECRETARY SILVESTRE H. BELLO III**, hereinafter called the “**DOLE**” and **REMAX INTERNATIONAL, INC.** with office address at No. 18 United St. Bo. Kapitolyo, Pasig City represented by its Network & Security System Unit Head, **MR. BRIAN D. TAN**, hereinafter called the “**SERVICE PROVIDER**”.

WHEREAS, the DOLE invited Bids for certain goods and ancillary services, viz., “**Lot 1 – Fifty (50) Units Desktop (Branded – Brand New) and Lot 3 – One Hundred Eleven (111) units Laptop (Branded - Brand New) of the project “Supply and Delivery of Various ICT Equipment for the DOLE – Central Office Productivity”** and the DOLE has accepted a Bid for **Lot 1 – Three Million Eight Hundred Thirty-Seven Thousand One Hundred Pesos only (₱3,837,100.00) and Lot 3 – Eight Million Five Hundred Seventy-Two Thousand Eighty-Six Pesos Only (₱8,572,086.00) hereinafter called the “Contract Price”**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Purchase Request;
 - ii. Schedule of Requirements;
 - iii. Technical Specifications;
 - iv. Supplemental/Bid Bulletin;
 - v. General and Special Conditions of Contract; and
 - vi. Purchase Order
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;

- iv. Notice of Award of Contract, and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of Lot 1 – Three Million Eight Hundred Thirty-Seven Thousand One Hundred Pesos only (₱3,837,100.00) and Lot 3 – Eight Million Five Hundred Seventy-Two Thousand Eighty-Six Pesos Only (₱8,572,086.00) or such other sums as may be ascertained, REMAX INTERNATIONAL, INC. agrees to supply and deliver Fifty (50) Units Desktop (Branded – Brand New) and One Hundred Eleven (111) Units Laptop (Branded – Brand New) in accordance with its Bid.

4. The DOLE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
