



CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of MAY 16 2022, 2022 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Muralla Wing cor. General Luna Street, Intramuros, Manila, represented by **SECRETARY SILVESTRE H. BELLO III**, hereinafter called the “**DOLE**” and **DIAMZON AND GOPEZ REFRIGERATION & AIRCONDITIONING INDUSTRIES, CO.** with office address at San Rafael Street, Saint Dominic Corinthian Phase 2 Dolores, City of San Fernando, Pampanga, represented by its Sales and Finance Manager, **MS. MARIVIC D. GOPEZ**, hereinafter called the “**CONTRACTOR**”.

WHEREAS, the DOLE invited Bids for certain goods and ancillary services, viz., “**Supply, Delivery and Installation of Twelve (12) Airconditioning Units Including Removal of Old and Defective Units for the Bureau of Local Employment**” and the DOLE has accepted a total Bid for **Two Million Nine Hundred Thousand Six Hundred Sixty-One Pesos and Twenty-five Centavos only (₱2,900,661.25)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Terms of Reference, Technical Specifications, Project and Location Plan and Supplemental/Bid Bulletin; and
 - iii. General and Special Conditions of Contract;
- ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract, and the Bidder’s conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that**

additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Two Million Nine Hundred Thousand Six Hundred Sixty-One Pesos and Twenty-five Centavos only (₱2,900,661.25)** or such other sums as may be ascertained, **Diamzon and Gopez Refrigeration & Airconditioning Industries, Co.** agrees to **Supply, Delivery and Installation of Twelve (12) Airconditioning Units Including Removal of Old and Defective Units for the Bureau of Local Employment** in accordance with its Bid.
4. The DOLE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

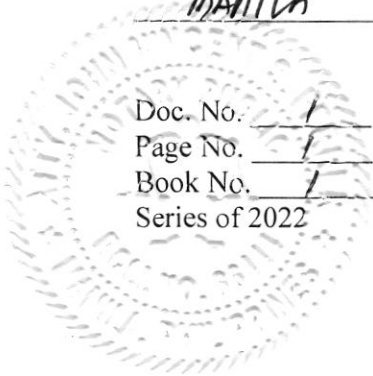
