Series of 2022**

**DECLARING GRAFIQ ADVERTISING SYSTEMS CORPORATION
AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE
PROJECT "SUPPLY AND DELIVERY OF PLAQUES FOR THE WINNERS OF
Y2022 AWARDING OF BEST DOLE-ASSISTED LIVELIHOOD PROJECTS"**

WHEREAS, the Department of Labor and Employment (DOLE), through the Bureau of Workers with Special Concerns (BWSC), requisitioned for the project "Supply and Delivery of Plaques for the Winners of Y2022 Awarding of Best DOLE-Assisted Livelihood Projects" with a total Approved Budget for the Contract of ₱170,700.00;

WHEREAS, the BAC Resolution No. 073, Series of 2022 recommending Small Value Procurement as the method of procurement for the abovementioned project was signed on 04 May 2022;

WHEREAS, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government E-Procurement Systems (PhilGEPS), DOLE website from 28 April 2022 to 02 May 2022;

WHEREAS, in response to the advertisement, two (2) bidders, namely: (1) Grafiq Advertising Systems Corporation; and (2) Speedprinter Microventures, Inc. submitted their price proposals and is summarized in the Abstract of Price Quotations attached as Annex A, wherein Speedprinter Microventures, Inc. declared as Lowest Calculated Bidder for the project;

WHEREAS, based on the Abstract for Price Quotation submitted by the BAC-TWG, Speedprinter Microventures, Inc. complied with the minimum requirements and its bid is below the approved budget for the contact of the project "Supply and Delivery of Plaques for the Winners of Y2022 Awarding of Best DOLE-Assisted Livelihood Projects";

WHEREAS, Speedprinter Microventures, Inc. submitted its financial and eligibility documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Speedprinter

Microventures, Inc. its bid has been found to be “**non-responsive**” because of failure to submit post qualification requirement (Mayor’s Permit) on time;

WHEREAS, the Secretariat sent a letter of Post-Disqualification to Speedprinter Microventures, Inc., within three (3) Days no MR was received by the BAC;

WHEREAS, BAC Secretariat sent a letter to Grafiq Advertising Systems Corporation requesting for submission of post-qualification documents;

WHEREAS, Grafiq Advertising Systems Corporation submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Grafiq Advertising Systems Corporation its bid has been found to be responsive;

WHEREAS, the Bureau of Workers with Special Concerns, made a justification on the change of the number of Plaques to be procured as follows:

WHEREAS, the BAC-Technical Working Group (TWG) recommended, **Grafiq Advertising Systems Corporation** as the **Second Lowest Calculated Bidder** for the **Bureau of Workers with Special Concerns** project “**Supply and Delivery of Plaques for the Winners of Y2022 Awarding of Best DOLE-Assisted Livelihood Projects**” based on the Abstract of Price Quotation and was declared **responsive** as indicated in the post-qualification report under Small Value Procurement;

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED**:

- a. To declare **Grafiq Advertising Systems Corporation** as the **Lowest Calculated and Responsive Bidder** for the **Bureau of Workers with Special**

Concerns project “Supply and Delivery of Plaques for the Winners of Y2022 Awarding of Best DOLE-Assisted Livelihood Projects”;

- b. To award the procurement of the project “Supply and Delivery of Plaques for the Winners of Y2022 Awarding of Best DOLE-Assisted Livelihood Projects” to **Grafiq Advertising Systems Corporation** via **Small Value Procurement**; at a Contract Price of **₱138,282.00**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
