## CONTRACT AGREEMENT

THIS AGREEMENT, made this \_\_\_\_ day of JUN 09 2022, 2022 by and between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary ATTY. ANA C. DIONE, CPA**, hereinafter called the “**DOLE**” and **EDGE CLOUD TECHNOLOGY AND SOLUTIONS CORPORATION** with office address at 5th Floor, Ongtiak Business Center, General Maxilom Avenue, Kamputhaw, Cebu City represented by its **President, MR. DARWIN J. CABILUNA**, hereinafter called the “**Service Provider**”.

**WHEREAS**, the **DOLE** invited Bids for certain goods and ancillary services, viz., for the project “**Subscription of Cloud Hosting Services for JobStart Philippines Digital Platforms**” of the **Bureau of Local Employment** and the **DOLE** has accepted a total Bid of **One Million Four Hundred Ninety-Nine Thousand Nine Hundred Eighty-Eight Pesos only (₱1,499,988.00)** hereinafter called the “**Contract Price**”.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications and Terms of Reference;
    - iii. General Conditions of Contract;
    - iv. Special Conditions of Contract;
    - v. Supplemental Bid/Bulletin No. 7
  - b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents / statements submitted;  
  
Bid form including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
  - c. Notice of Award of Contract and Bidder’s conforme thereto;
  - d. Performance Security;
  - e. Purchase Order; and

- f. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice To Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **One Million Four Hundred Ninety-Nine Thousand Nine Hundred Eighty-Eight Pesos only (₱1,499,988.00)** or such other sums as may be ascertained, the Service Provider agrees to provide for the project **“Subscription of Cloud Hosting Services for JobStart Philippines Digital Platforms”** of the **Bureau of Local Employment** in accordance with its Bid.
4. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.






