**DECLARING FILCRAFTERS, INC. AS THE LOWEST CALCULATED  
AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF  
TWO (2) UNITS EXECUTIVE TABLES**

**WHEREAS**, the Department of Labor and Employment (DOLE), through the Legal Service (LS), requisitioned the "Supply and Delivery of Two (2) units Executive Tables" with a total Approved Budget for the Contract of ₱100,000.00;

**WHEREAS**, the said activity is included in the FY 2022 Annual Procurement Plan of the Department;

**WHEREAS**, DOLE BAC Resolution No. 077, Series of 2022 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 16 May 2022;

**WHEREAS**, DOLE advertised the Request for Price Quotation for the procurement of the above-mentioned project in the DOLE Website, and Philippine Government E-Procurement System (PhilGEPS) from 17 May 2022 to 20 May 2022;

**WHEREAS**, in response to the advertisement, three (3) bidders, 1) Christine-Arcy Furniture Designs, Inc., 2) Filcrafters, Inc. and 3) Suntawood Home and Office, Inc. submitted Bid Proposals on the opening of bids scheduled on 20 May 2022;

**WHEREAS**, the BAC-TWG recommended Filcrafters, Inc. as the Lowest Calculated Bidder based on the Abstract of Price Quotation and was declared **responsive** as indicated in the post-qualification report under small value procurement;

**NOW, THEREFORE**, for and in consideration of the foregoing, We, the members of the DOLE BAC hereby resolve as it is hereby **RESOLVED**:

- a. To declare **Filcrafters, Inc.** as the Lowest Calculated and Responsive Bidder for the project "Supply and Delivery of Two (2) units Executive Tables";


- b. To award the "Supply and Delivery of Two (2) units Executive Tables" to **Filcrafters, Inc.**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
