**DECLARING TOYOTA QUEZON AVENUE, INC. AS THE LOWEST
CALCULATED AND RESPOSIVE BIDDER FOR THE ADMINISTRATIVE
SERVICE'S PROJECT "SUPPLY AND DELIVERY OF FOUR (4) BRAND NEW
SERVICE VEHICLES FOR THE DEPARTMENT OF LABOR AND EMPLOYMENT –
CENTRAL OFFICE"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the competitive bidding of the project "Supply and Delivery of Four (4) Brand New Service Vehicles for the Department of Labor and Employment - Central Office" with an Approved Budget for the Contract (ABC) of ₱5,400,000.00 in the Philippine Government E-Procurement System (PhilGEPs), DOLE Website and conspicuous places at the DOLE's premises from 13 May 2022 to 07 June 2022;

WHEREAS, said project is included in the FY 2022 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference scheduled on 24 May 2022 was attended by five (5) bidders namely: (1) Toyota Balintawak, Inc.; (2) Nissan Commonwealth; (3) Toyota Global City; (4) MCX International, Inc.; and (5) AutoHub, Inc.;

WHEREAS, in response to the advertisement, two (2) bidders, Toyota Quezon Avenue, Inc. and Toyota Balintawak purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 13 June 2022;

WHEREAS, the submission and opening of bids scheduled on 07 June 2022 was moved on 14 June 2022, was attended by Toyota Quezon Avenue, Inc. and Toyota Balintawak, Inc. The said bidders submitted their technical and financial envelopes. After the conduct of preliminary examination, the technical proposals of Toyota Quezon Avenue, Inc. and Toyota Balintawak, Inc. were rated as "**passed**". Hence, the BAC opened the financial envelopes of Toyota Quezon Avenue, Inc. and Toyota Balintawak, Inc. which were also rated as "**passed**";

WHEREAS, the BAC - TWG in its bid evaluation report dated 15 June 2022 as duly concurred by the members of the BAC, examined and evaluated the bid proposals of Toyota Quezon Avenue, Inc. and Toyota Balintawak, Inc.;

WHEREAS, based on the foregoing evaluation of the bids conducted by the DOLE-BAC (TWG), Toyota Quezon Avenue, Inc. and Toyota Balintawak, Inc.

complied with the mandatory minimum technical specifications of the said project. Toyota Quezon Avenue, Inc. was declared as the Lowest Calculated Bidder per BAC Resolution No. 105, Series of 2022;

WHEREAS, the BAC Secretariat sent a letter to Toyota Quezon Avenue, Inc. requesting for submission of additional documents for post-qualification;

WHEREAS, Toyota Quezon Avenue, Inc. submitted additional documents for post-qualification;

WHEREAS, the BAC – TWG conducted post-qualification of Toyota Quezon Avenue, Inc. Upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Toyota Quezon Avenue, Inc. its bid has been found to be responsive for its legal and financial requirements;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Toyota Quezon Avenue, Inc.** as the **Lowest Calculated and Responsive Bidder** for the **Administrative Service's** project **"Supply and Delivery of Four (4) Brand New Service Vehicles for the Department of Labor and Employment - Central Office"**;
- b. To award the procurement of the project **"Supply and Delivery of Four (4) Brand New Service Vehicles for the Department of Labor and Employment - Central Office"** of the **Administrative Service** to **Toyota Quezon Avenue, Inc.**, at a contract price of **₱4,816,800.00**; and
- c. To recommend for approval by the DOLE Secretary the foregoing findings.
