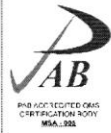

## CONTRACT AGREEMENT

THIS AGREEMENT, made this JUL 13 2022 day of \_\_\_\_\_, 2022 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, General Luna corner Muralla Streets, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **VJ GRAPHIC ARTS, INC.** with office address at 12 NO Future Point Plaza 2, 115 Mother Ignacia Avenue, South Triangle, Quezon City, represented by its Director **MR. PERCIVAL D. DATU**, hereinafter called the “**Supplier**”.

**WHEREAS**, the DOLE invited Bids for certain goods and ancillary services, particularly “Printing of Frequently Asked Question (FAQs) Booklet of the Department Order Nos. 221-21, 216-20 and 217-20” and the **DOLE** has accepted a total Bid for **One Hundred Forty Two Thousand One Hundred Eighty Seven Pesos and 50/100 Only (P142,187.50)**, hereinafter called the “**Contract Price**”.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including

- corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto;
- v. Performance Security; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract**

3. In consideration for the sum of **One Hundred Forty Two Thousand One Hundred Eighty Seven Pesos and 50/100 (P142,187.50)** or such other sums as may be ascertained, VJ Graphic Arts Inc. agrees to provide "**Printing of Frequently Asked Question (FAQs) Booklet of the Department Order Nos. 221-21, 216-20 and 217-20**" in accordance with its Bid.
4. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

**IN WITNESS** whereof, the parties thereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




