**DECLARING PEOPLE DYNAMICS, INC. AS THE LOWEST
CALCULATED AND RESPONSIVE BIDDER FOR THE HUMAN
RESOURCE DEVELOPMENT SERVICE PROJECT "USE OF ONLINE
ASSESSMENT/TESTING FOR ONE (1) YEAR"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the competitive bidding for the Human Resource Development Service project "Use of Online Assessment/Testing for One (1) Year" with an Approved Budget for the Contract (ABC) of ₱448,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 10 June 2022 to 05 July 2022;

WHEREAS, said project is included in the FY 2022 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference scheduled on 21 June 2022 was attended by lone prospective bidder, People Dynamics, Inc.;

WHEREAS, in response to the advertisement, two (2) bidders People Dynamics, Inc. and MyBusybee Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 01 July 2022;

WHEREAS, the submission and opening of bids scheduled on 05 July 2022 was likewise moved on 12 July 2022. It was attended by two (2) bidders People Dynamics, Inc. and MyBusybee Inc. The said bidders submitted their technical and financial envelopes. After the conduct of preliminary examination, the technical proposals of People Dynamics, Inc. and MyBusybee Inc., were rated as "**passed**". Hence, the BAC opened their financial envelopes which were also rated as "**passed**";

WHEREAS, the BAC - TWG in its bid evaluation report dated 18 July 2022 as duly concurred by the members of the BAC, examined and evaluated the bid proposals of People Dynamics, Inc. and MyBusybee Inc.;

WHEREAS, based on the foregoing evaluation by the TWG, the two bidders complied with the mandatory minimum technical specifications. However, MyBusybee Inc. offered the lowest bid amount for the said project, was declared as the Lowest Calculated Bidder per BAC Resolution No. 116, Series of 2022;

WHEREAS, the BAC Secretariat sent a letter to MyBusybee Inc. requesting for submission of post-qualification documents;

WHEREAS, MyBusybee Inc. submitted additional documents for post-qualification;

WHEREAS, upon Client Verification with the Completed Contracts of MyBusybee Inc. it was found out that it has unsatisfactory performance with its previous completed contract with the Department particularly the project "**Development and Deployment of Online Job Fair System**" for the year 2021.

WHEREAS, the BAC TWG conducted post-qualification of MyBusybee Inc. Upon careful examination, validation and verification, MyBusybee Inc. legal and financial requirements was found to be responsive except for the technical aspect particularly the Single Largest Completed Contract which is not similar to the contract to be bid and the supplier failed to accomplish the deliverables and/or certain systems were not working properly on the targeted date of completion. MyBusybee Inc. was rated as "**Non-Responsive**" and thus, shall be subjected to the issuance of notice of post-disqualification;

WHEREAS, BAC Secretariat sent a letter of Post-Disqualification to MyBusybee Inc. after three (3) Days, MyBusybee Inc. submitted a Motion for Reconsideration;

WHEREAS, the MR of MyBusybee Inc. was denied;

WHEREAS, BAC Secretariat sent a letter to People Dynamics, Inc., as the Second Lowest Calculated Bidder requesting for submission of post-qualification documents;

WHEREAS, People Dynamics, Inc. submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by People Dynamics, Inc. its bid has been found to be responsive;


NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **People Dynamics, Inc.** as the **Lowest Calculated and Responsive Bidder** for the **Human Resource Development Service** project "**Use of Online Assessment/Testing for One (1) Year**";
- b. To award the procurement of the project "**Use of Online Assessment/Testing for One (1) Year**" for the **Human Resource Development Service** to **People Dynamics, Inc.** as the **Lowest Calculated and Responsive Bidder** at a contract price of **₱448,000.00**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.




