DOLE BAC Resolution No. 111

Series of 2022

DECLARING TOYOTA GLOBAL CITY, INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY AND DELIVERY OF SEVEN (7) BRAND NEW VEHICLES FOR THE OFW HOSPITAL"

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the competitive bidding of the project "Supply and Delivery of Seven (7) Brand New Vehicles for the OFW Hospital" with a total Approved Budget for the Contract (ABC) of ₱10,000,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 12 May 2022 to 7 June 2022;

WHEREAS, said project is included in the approved FY 2022 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference scheduled on 24 May 2022 was attended by five (5) bidders, namely: 1) Toyota Balintawak, Inc., 2) Toyota Global City, Inc., 3) Nissan Commonwealth, Inc. 4) MCX International, Inc., and 5) Autohub Inc.;

WHEREAS, in response to the advertisement three (3) bidders, namely: 1) Toyota Quezon Avenue, Inc., 2) Toyota Balintawak, Inc. and 3) Toyota Global City, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

WHEREAS, during the submission and opening of bids scheduled on 7 June 2022, three (3) bidders, namely: 1) Toyota Quezon Avenue, Inc., 2) Toyota Balintawak, Inc. and 3) Toyota Global City, Inc. submitted their technical and financial envelopes. Upon eligibility check, the three (3) bidders were rated as "passed". Hence, the BACTechnical Working Group (TWG) opened the financial envelopes of the three (3) eligible bidders which were likewise found to be compliant and recommended for bid evaluation.

WHEREAS, based on the evaluation of the bids conducted by the BAC-TWG on 8 June 2022, Toyota Global City, Inc. was declared as the Lowest Calculated Bidder per BAC Resolution No. 96, Series of 2022 for the project "Supply and Delivery of Seven (7) Brand New Vehicles for the OFW Hospital";

WHEREAS, on 10 June 2022, the BAC Secretariat sent a notice to Toyota Global City, Inc. requesting for submission of post-qualification documents;

WHEREAS, on 13 June 2022, Toyota Global City, Inc. submitted its post-qualification documents;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Toyota Global City, Inc., its bid have been found to be responsive;

NOW, THEREFORE, We, the members of the DOLE BAC, hereby **RESOLVE** as it is hereby **RESOLVED**:

- To declare Toyota Global City, Inc. as the Lowest Calculated and Responsive Bidder for the project "Supply and Delivery of Seven (7) Brand New Vehicles for the OFW Hospital;
- b. To award the project "Supply and Delivery of Seven (7) Brand New Vehicles for the OFW Hospital" to Toyota Global City, Inc. at a contract price of P8,409,900.00; and
- c. To recommend for approval by the DOLE Secretary the foregoing findings.
