**DECLARING TANJER ENTERPRISES AS THE SINGLE CALCULATED
AND RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY AND DELIVERY
OF CUSTOMIZED JOBSEEKER'S KIT FOR PROMOTION OF PHILJOBNET
AND CAREER INFORMATION SYSTEM"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the competitive bidding of the project "Supply and Delivery of Customized Jobseeker's Kit for Promotion of PhilJobnet and Career Information System" with a total Approved Budget for the Contract (ABC) of ₱401,600.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 5 July 2022 to 2 August 2022;

WHEREAS, said project is included in the approved FY 2022 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference scheduled on 12 July 2022 was attended by Tanjer Enterprises, Rulujac Enterprise, and Jaja Trading;

WHEREAS, in response to the advertisement, only Tanjer Enterprises purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

WHEREAS, Supplemental /Bid Bulletin No. 14, Series of 2022 was issued to clarify or amend some provisions originally indicated in the Bidding Documents specifically on Invitation to Bid, Section VI. Schedule of Requirements and Section VII. Technical Specifications;

WHEREAS, during the 02 August 2022 Submission and Opening of Bids only Tanjer Enterprises submitted its technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of Tanjer Enterprises was rated as "**passed**". Hence, the BAC-Technical Working Group (TWG) opened the financial envelopes which was likewise found to be compliant and recommended for bid evaluation.

WHEREAS, based on the evaluation of the bids conducted by the BAC-TWG on 15 August 2022, **Tanjer Enterprises** was declared as the Single Calculated Bidder per BAC Resolution No. 130, Series of 2022 for the project “**Supply and Delivery of Customized Jobseeker’s Kit for Promotion of PhilJobnet and Career Information System**”;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **Tanjer Enterprises** its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the DOLE BAC, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Tanjer Enterprises** as the Single Calculated and Responsive Bidder for the project “**Supply and Delivery of Customized Jobseeker’s Kit for Promotion of PhilJobnet and Career Information System**”;
- b. To award the project “*Supply and Delivery of Customized Jobseeker’s Kit for Promotion of PhilJobnet and Career Information System*” to **Tanjer Enterprises** at a contract price of **P393,200.00**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
