**DECLARING PETRON CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE RE-BIDDING OF THE PROJECT “PROCUREMENT OF FUEL (GASOLINE AND DIESEL) THROUGH FLEET CARD FOR THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE-CO) MOTOR VEHICLES FOR ONE (1) YEAR”**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the re-bidding of the abovementioned project with an Approved Budget for the Contract (ABC) of ₱8,058,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE’s premises from 14 June 2022 to 05 July 2022;

**WHEREAS**, said project is included in the approved FY 2022 Annual Procurement Plan of the Department;

**WHEREAS**, the Pre-bid Conference scheduled on 21 June 2022 was attended by Petron Corporation and Pilipinas Shell Petroleum Corporation;

**WHEREAS**, in response to the advertisement, only Petron Corporation purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

**WHEREAS**, the BAC issued a notice informing the prospective bidder/s that the schedule of the Submission and Opening of Bids has been moved from 05 July 2022 to 12 July 2022;

**WHEREAS**, during the submission and opening of bids, only Petron Corporation submitted its technical and financial envelopes. Upon eligibility check, the technical component of the lone bidder was rated as “**passed**”. Hence, the BAC-Technical Working Group (TWG) opened the financial envelope which was likewise found to be compliant and recommended for bid evaluation. The BAC approved the TWG’s recommendation and instructed the TWG to conduct immediate bid evaluation;

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE-BAC TWG, Petron Corporation was declared as the Single Calculated Bidder per BAC Resolution No. 118, Series of 2022;

**WHEREAS**, on 20 July 2022, the BAC Secretariat sent a notice to the Petron Corporation requesting for submission of post-qualification documents;

**WHEREAS**, on 25 July 2022, Petron Corporation submitted their post-qualification documents;

**WHEREAS**, upon careful examination, validation and verification of all the documents submitted by Petron Corporation, its legal, technical and financial requirements were found to be responsive;

**NOW, THEREFORE, We**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To declare Petron Corporation as the Single Calculated and Responsive Bidder for the bidding of the project “**Procurement of Fuel (Gasoline and Diesel) through Fleet Card for the Department of Labor and Employment (DOLE-CO) Motor Vehicles for One (1) Year**”;
2. To award the project “**Procurement of Fuel (Gasoline and Diesel) through Fleet Card for the Department of Labor and Employment (DOLE-CO) Motor Vehicles for One (1) Year**” to **Petron Corporation** at a contract price of **₱ 8,057,000.00**; and
3. To recommend for approval by the DOLE Secretary the foregoing findings.
