CONTRACT AGREEMENT

THIS AGREEMENT, made this 24 AUG 2022 day of _____, 2022 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, corner Muralla and General Luna Streets, Intramuros, Manila, represented by **UNDERSECRETARY CIRIACO A. LAGUNZAD III**, hereinafter called the “**DOLE**” and **DAIKIN AIRCONDITIONING PHILIPPINES, INC.**, with office address at 18TH Floor Exxa Tower, Bridgetowne, C-5 Road, Brgy. Ugong Norte, Quezon City represented by its Manager, **MS. CHERRY MARCELINO**, hereinafter called the “**SUPPLIER**”.

WHEREAS, the DOLE invited Bids for certain goods and ancillary services, viz., “**Supply of Parts and Labor for the Repair of Daikin VRV III Centralized Airconditioning System Installed at the 7th Floor, DOLE Main Building**” and the DOLE has accepted a Bid for **One Hundred Fifty-Eight Thousand Twenty-three Pesos and Ten Centavos only (P158,023.10)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Purchase Request;
 - ii. Submitted Quotations and all other documents or statements submitted;
 - iii. Notice of Award of Contract, and the Bidder's conforme thereto;
 - iv. Job Order; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **One Hundred Fifty-Eight Thousand Twenty-three Pesos and Ten Centavos only (₱158,023.10)** or such other sums as may be ascertained, **DAIKIN AIRCONDITIONING PHILIPPINES, INC.** agrees to supply parts and labor for the repair of Daikin VRV III Centralized Airconditioning System Installed at the offices of Undersecretary Benedicto Ernesto R. Bitonio Jr., Assistant Secretary Paul W. Añover and former Assistant Secretary Mariano R. Alquiza, 7th Floor DOLE Main Building” in accordance with its Bid.
4. The DOLE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






